- Greystones Community National School held their official opening 15th February 2023
- ETB Day 2nd March 2023; KWETB had 2 entries shortlisted for this event, one entry from Athy College and one from Bray Youthreach.
- Increased allocation of Deputy Principals for KWETB schools; for the upcoming academic year KWETB post-primary schools will have 4 more Deputy Principal posts.
- Increased advertising has just launched for over 280 teaching posts.
- KWETB's Leadership & Management Forum received an initial training and information session on Public Sector Duty this month.
- A new apprenticeship programme (Wind Turbine Technician) has been developed by Kerry ETB and KWETB. KWETB is now approved to deliver same and are actively looking for a facility to deliver the necessary training into the future. This requires a standalone facility.

## No.8 Buildings Report

The Director of OSD gave an executive summary of the report as provided, noting the core highlights of the report and high-level projects. The Board were updated that the Department of Education (DE) were reviewing their work programme for the year and so far 58 projects have been put on hold including Greystones Community College and the Kilbride Campus projects. These are the only projects KWETB have yet been informed of as delayed. The DE's immediate priority is to ensure school places for September 2023 and accommodating additional needs students, delivering same through the 'Devolved SEN Reconfiguration and Modular Accommodation programme' which provides the services of a project manager to assist the school authority. It is anticipated that the use of the DoE procurement framework will prove quicker than individual tendering at local level. These project managers are already on site and engaging with the school management and design teams in situ to prepare reports for the DE for solutions. The disappointment with a lack of long-term planning and timelines was expressed by members. The CE confirmed all assurances provided are based on DE assurance to the ETB and the intentions are not to compromise longer term plans in prioritising September 2023.

Further detail was provided on Blessington Community College school extension, noting the modular accommodation to cater for 800 pupils has since been revised to the refurbishment of existing prefabricated accommodation and the relocation of additional prefabs from Craddockstown, Naas. We are currently awaiting formal approval from the Department of Education for the refurbishment works and also awaiting clarification regarding increasing the LTPE from 800 to 1000 pupils. It was clarified that the prefabs have not yet been relocated and there is no available date for relocation yet. The SEN modular unit at Blessington Community College is almost complete with snagging underway.

Update was provided on the BIFE refurbishment of the roof and repair of the perimeter fence and Gaelcholáiste Mhaigh Nuad Refurbishment of existing classrooms. There was no further update available on Confey College in relation to their flood risk location and ASD unit plans other than provided in the written buildings report.

Thanks were expressed to the Building teams for work completed at Athy FETC on the roof enhancing their workplace and learning setting.

Maynooth Community College has agreed to increase their enrolment from 170 to 200 upon DE request and teacher allocations will increase in response.

9.1 Letter to Board from Blessington Community College Parents Council

The Chair offered for Cllr Patsy Glennon to speak on the above, acknowledging that Cllr Glennon has raised the Blessington Community College school numbers and accommodation matters numerous times at Board meetings and liaising on the school's behalf outside of same.

Cllr Glennon acknowledged the letter from the Parents Council. He referenced the two issues at present for Blessington Community College; the immediate September needs and the longer term in relation to numbers which the school should to cater for. He noted the delays were at DE decision level and he accepts the assurances received from the ETB Executive, based on DE assurances, that the September
