No. 5 Chief Executive update

The report was taken as read and the CE gave an overview of the items within. As this was the last meeting of the current board the CE report outlined some of the significant achievements of KWETB over the last 5 years. The following points were within;

• 4 state of the art school buildings were delivered and occupied by students, Maynooth PPS, Maynooth CC, Naas CC and Greystones CNS.



- Dedicated resources to support the Ukrainian and International Protection applications students enrolling in primary and post primary education.
- Ethos co-ordinator appointed to support the delivery of the Patron's Framework.
- Special school identified for located at Craddockstown.
- Transitioning of financials to ESBS Payroll Shared Services.
- Completion of Corporate Governance Programme.
- Development of new corporate brand, new website and staff intranet.
- Establishment of dedicated Procurement unit and reduction of non-compliant procurement from approx. €2.9m in 2019 to €693K in 2023.
- Commitment and progress on Public Sector Duty, including a web accessibility project.
- Establishment of Manufacturing Training Facility in Celbridge.
- Increase in FET budget.

Members of the Board commented on the achievements of KWETB. It was suggested that Wicklow County would benefit from a similar facility to that of Celbridge Manufacturing Training Facility. Thanks, were expressed to all staff across KWETB who have worked hard to ensure the provision of education and training is a benchmark for education across the two regions, particularly when faced with challenges such as Covid-19 in recent years. The strong ethos of KWETB was recognised as was the work of the Executive in leading KWETB.

Cllr. Patsy Glennon welcomed the update on the Blessington extension but noted the commencement date had been extended. Positive news on the delivery of the temporary accommodation on site was acknowledged.

Queries were raised around the progress on the Pipers Hill campus in terms of safety works and other matters. It was confirmed that KWETB are not responsible for the broken fence referred to but have been engaging with the responsible principal regarding same. Initial safety works are currently underway however the possibility of a 2nd entrance to the campus is still under consideration at Department level, and the challenges to facilitating a 2nd entrance. Other options have been evaluated and safety is the paramount concern for KWETB.

It was confirmed that KWETB have received no formal communication on the development of Greystones CC. Gaelcholiste Na Mara is a challenging project but is being progressed and supported.

Any amendment to admission policies or catchment area definitions for Greystones and Kilcoole will have to be aligned and reflective of population growth. Should any outside party wish to use school facilities it was confirmed they should contact the principal of the school.

After queries from members of the Board it was confirmed that no name has been decided for the new College of the Future located at BIFE. It was suggested that any name would reflect its location in Bray. Representatives from BIFE are involved in the renaming discussions, SOLAS strategy and naming convention has to be considered, as does any national naming conventions of Colleges of the Future.
