Chief Executive's welcome

The Chief Executive Dr. Deirdre Keyes welcomed the Board members along with the newly elected NPC appointee, she reiterated that no male nominee for parent representative was received from NPC but that KWETB have been advised that a male nominee will be forthcoming on the commencement of the academic term. We have a vacant position of female staff representative and an election for appointment of same will be held in the coming months.

The CE confirmed that this meeting of the Board had a specific agenda that is set out under the ETB Act 2013. It is procedural and precludes the Board from conducting any other business other than those provided for under legislation. Constitution of the Committees of the Board, including the Audit and Risk and Finance Committees and Board of Managements will take place at the September meeting of the Board. Approval of Terms of Reference for those committees will also occur in September. The election of Chair of the Board will take place in September, and for today's meeting, the Chief Executive will facilitate the meeting. The Board was advised that training to assist them in their role as Board members will be provided by KWETB in September and further training provided by ETBI in October.
